Shelf Life & Storage

- Shelf Life: 5 years from date of manufacture under recommended storage.
- Storage Conditions: Store in a cool, dry, and well-ventilated place at 15–25°C. Protect from heat, direct sunlight, moisture, and air, as menthol is volatile and may sublime on prolonged exposure. Keep the container tightly closed in the original, properly labeled, airtight container. Store away from strong oxidizing agents, ignition sources, and open flames to maintain product quality, purity, and stability.

Applications

- Use: Widely used as a cooling agent, flavoring agent, and fragrance ingredient in pharmaceutical, food, nutraceutical, cosmetic, oral care, and personal care formulations. It provides a cooling sensation and is commonly incorporated into cough drops, lozenges, inhalants, vapor rubs, balms, ointments, creams, gels, mouthwashes, toothpastes, chewing gum, confectionery, beverages, shampoos, soaps, and massage products. It is also used in aromatherapy and topical formulations to provide a refreshing sensory effect.
