Keep the container tightly closed in the original, properly sealed packaging to prevent moisture absorption and contamination. Store away from strong oxidizing agents, strong acids, alkalis, and incompatible materials. Use clean, dry handling equipment during dispensing to maintain the product's color strength, purity, free-flowing properties, and overall quality throughout its shelf life.

Applications
